To the Businesses on the New Bern Avenue Corridor:

New Bern Avenue, from downtown Raleigh to New Hope Road, is a critical transportation connection providing access to hundreds of businesses including the WakeMed Raleigh Medical Campus. It has a rich cultural history, now diverse in race, age, and income levels. As our city rapidly grows, the addition of Bus Rapid Transit (BRT) is an exciting improvement that will better meet transit demands and get riders where they need to go faster. When the new BRT route is complete, the New Bern Avenue corridor will become a more walkable and accessible district for our citizens who live and work here, and for our businesses located here. Our citizens will experience easier connectivity to businesses, schools, faith communities, and to I-440 and 540. Employees of area businesses will have another way to get to and from work. Frequent and reliable transit on this corridor will positively impact residents and businesses along this line and ensure the future success of the New Bern Avenue corridor.

Before the completion of this BRT line becomes a reality in the summer of 2025, there may be challenges for our businesses along this planned route. Utility setbacks and construction begin in the fall of 2023 and will continue over the next two years. To support businesses during this period and ensure equitable economic growth, the Bus Rapid Transit Business Resource Collaborative and this Business Resource Guide will provide informative updates on the project. The BRT Business Resource Collaborative will provide project update meetings, business workshops, a monthly e-newsletter, and more. Our goals are to help offset impacts to businesses during construction and to offer tools to prepare businesses for the exciting opportunities that lie ahead.

As your elected leaders we are committed to the success of the New Bern Avenue corridor. We are excited about the opportunities that the new BRT route presents for our citizens and businesses. And we are here to help businesses thrive in the months ahead.



# **BUS RAPID TRANSIT (BRT) IS COMING TO NEW BERN AVENUE**

# WHAT IS BUS RAPID TRANSIT, OR BRT?

The Federal Transit Administration defines BRT as a high-capacity, bus-based transit system that delivers fast and efficient service.

Many other enhancements put BRT a cut above our existing bus system:

- **Better buses.** Longer buses hold more passengers, and with doors on both sides and lower floors, boarding is easier. They bend to go around corners!
- Longer hours. BRT bus schedules begin earlier and end later each day.
- **Less waiting**. Buses come by approximately every 10 minutes. They are faster and stay on schedule because they control traffic signals in the corridor and drive in dedicated lanes in some places.
- **Smart, weather-protected stations.** Riders can see live, accurate bus arrival times based on GPS tracking on BRT buses. Fares are collected at the station, so no fumbling for your wallet while boarding the bus.
- **Improved accessibility.** At stations inside I-440, walk onto buses from the elevated station platform without taking a step up. Riders can even roll bikes, strollers, or wheelchairs directly onto the bus.

# HOW WILL NEW BERN AVENUE CHANGE?

Many things will stay the same.

Changes you can expect to see very soon:

- Utilities are being moved back to make room for the dedicated BRT lanes.
- Ten weather-protected BRT stations will be built along the 5.1-mile New Bern Ave. corridor.
- Dedicated BRT bus lanes will be established in part of the corridor.

Over time, new zoning and development rules will allow more people to live and work near the New Bern Avenue BRT line. The project encourages denser development and taller buildings within walking distance of the BRT. As currently proposed, these properties will fall under the Transit Overlay District zoning along New Bern Avenue, which allows buildings up to five stories inside the Beltline and between five to seven stories outside the Beltline. The Transit Overlay district zoning also offers incentives for developers to build affordable housing, and to create jobs.

The BRT corridor will be rich in high-quality public spaces that make it comfortable — and safe — to walk to and from the bus stations. The transit-oriented development will encourage walking and browsing with safer sidewalks, plazas, places to rest, and <u>art installations</u> highlighting the culture and history of New Bern Avenue.

Construction will begin in the fall of 2023. And GoRaleigh expects between 2,500 and 3,000 riders each day when the New Bern Avenue route opens in the fall of 2025.

## NEXT STEPS IN THE CONSTRUCTION SCHEDULE: WHAT TO EXPECT?

In preparation for construction, a dozen private utility companies are relocating services in path of the project. Duke Energy began their work first, clearing trees, branches, and underbrush within Electrical Utility Easements (EUEs), Public Utility Easements (PUEs), along Right of Ways, and other permanent easements. About a dozen different utilities have work to do for this project.

#### **BRT STATIONS**

Conceptual designs for Wake BRT stations were created using comments from the Spring 2021 Virtual Open House and feedback from stakeholders and municipal partners. Watch the video below showcasing the new designs, which show proposed amenities, including pedestrian and cyclist access.




Construction is planned to be completed in the fall of 2025.

## WHAT YOU NEED TO KNOW ABOUT THE BRT ZONING AND REZONING

Transit-oriented development is designed to create active, vibrant areas where pedestrians can safely and easily walk, rest, and shop near the New Bern Avenue BRT stops when they are using the BRT system. A transit overlay district is a zoning regulation that guides developers and businesses in creating transit-oriented development. The zoning controls the size and location of buildings and establishes requirements for trees, streets, and sidewalks.

In October 2021, in anticipation of the BRT service, the Raleigh City Council added a <u>Transit</u> <u>Overlay District (TOD)</u> to its zoning code. Many properties near New Bern Avenue affected by the TOD are already zoned for commercial and multi-family development. City planners are asking to add the Transit Overlay District to the current New Bern Avenue zoning map.




Some of the changes outlined in the Transit Overlay District:

- Increases the number of people who live and work near New Bern Ave., which will increase business along the BRT routes.
- Moves buildings closer to the street.
- Ensures public spaces near the BRT stations are comfortable for walking, and includes plazas, more attractive street design, and safe pedestrian crossings.
- Allows developers to build taller buildings if they include affordable housing or are entirely for job creation.
- Does not require driveways or parking spaces.
- Restricts car-oriented businesses (existing businesses can continue current operations).

## **PROPERTY TAX CHANGES**

A logical question with talk of new zoning and rezoning is, "Will my property taxes change?" Here is a quick refresher on how and when Wake County assesses tax rates.

The next property tax reappraisal for Wake County is January 1, 2024. Reappraisals affect all residential property, commercial land, and structures. Under NC law, real estate is appraised at its fair market value, which is the most probable price a property would bring in a competitive open market.

Wake County will determine the selling price of similar properties and consider other factors to set its value, such as how old a building is, what condition it is in, what it would cost to replace it, and how much longer the building is likely to last.

Under <u>NC General Statute 105-317.1(c)</u>, you may appeal Wake County's assessment within 30 days of the first notice you receive. Appraised values are in effect until the next countywide reappraisal, which happens every four years.



## **CRAFTING A PROFESSIONAL BUSINESS PLAN**

When you began your business, you probably had a business plan. It might have been something informal that simply described the type of product or service you planned to sell, how much you were planning to invest, what the potential profits would be, and so on. Those details might even have been stored in your head. But if you are now ready to attract partners, funders, or investors, it's probably time to put together a more polished version of that plan. Here are some quick tips and a template that can guide you.

A professional business plan has three basic uses — communication, management, and planning.

As a **communication tool**, a business plan attracts investment capital, secures loans, appeals to top talent, and assists in attracting strategic business partners.

A comprehensive business plan shows whether your business has profit potential. It helps you take a realistic look at the entire business and then lets you show potential problems and solutions you've identified before launching your business.

As a **management tool**, the business plan helps you track, monitor, and evaluate your progress. It is a living document, which you will modify as you gain knowledge and experience. By using your business plan to set timelines and milestones, you can track your progress toward actual accomplishments.

As a **planning tool**, a business plan guides you through your business phases and can help identify roadblocks to avoid. Many business owners share their business plans with their employees to foster a broader understanding of where the business is going.
